Report from Prairie to Pine Regional Reps 2023

Your Regional reps are Donna Newton and Susan Phillips. Both attended the Regional meeting, during a heat wave, from Thursday June 1 to Sunday June 4th at (the not air conditioned) United Church in Meadowood in Winnipeg.

The Regional meeting was an opportunity to share worship, reports and updates from Region, our Theological Colleges, General Council, our retirees (7), our 3 Candidates for Ministry, our Regional Program Staff and the moderator of the United Church. We were able listen to information on issues, including a remit regarding an autonomous National Indigenous Organization within the United Church of Canada. (The NUC Board voted in favour of this remit at our Nov. meeting). The regional meeting allows plenty of time to discuss issues, and just get to know the folks at our tables. And we honoured those we have lost since our last regional meeting in the spring of 2022.

Our overall impressions:

We are blessed with a truly inspiring and dedicated and energetic moderator, the Right Reverend Dr. Carmen Lansdowne! Rev Chad was quite impressed!

The youth is alive and well in the United Church of Canada! Young people took leadership roles in music and worship, and M & S fundraising. In just 3 days, \$7760 was raised for M & S.

Music and worship, which happen many times throughout the meeting, were inspirational, moving, up-lifting and generally just a delight to experience.

A number of workshop options were available on Saturday. Donna and I chose "Worship in the Wild" and experienced a wonderfully spiritual walk in a little wild space right in the city. We found quiet spots along the path for Call to Worship, scripture readings (by members of the youth contingent), and Prayers of Thanksgiving. Three experts where there to share knowledge—an ornithologist, and entomologist and an arborist. Even in the heat, we were wishing we had more time! A second workshop involved singing and an update about a new digital hymnal that is being developed and we'll hear more about in 2024.

At dinner on Saturday evening we had the privilege of listening to our retirees share their experiences and wisdom gleaned from years of ministering in all sorts of places.

The meeting ended with a very moving worship service Sunday morning. We were in a beautiful building without air conditioning, on a very hot day, following 3 also very hot days. And even though you might imagine that it would be very difficult to stay focused, it was anything but. The service included ordination, commissioning and admitting of new clergy. It included communion, a sermon from The Right Reverend Carmen Lansdowne, and it included amazing music.

This meeting is such a gift. There is no better way to connect with people who share so many of the same hopes and dreams and concerns—for our church, our communities and our world. Technology has served us well the last few years, but this is a whole other level of sharing, learning, discerning, and growing in faith.

Board of Trustees Report

Leona Kucher has been acting as a trustee on the NUC board and is on the 2nd year of her 2 year term which began in 2022. Dave Cochrane was acting trustee from 2021 to 2022.

There are 2 other trustees, Eleanor Nicholson and Gayle Johnson. Eleanor will become acting trustee after the annual meeting on February 4th.

The 3 of us met with Dave Cochrane in May of 2023 to discuss the job of trustees. Leona was to be active for 2023. Elenor for 2024 and Gayle for 2025.

There are always to be 3 trustees named, in case one may not be able to be active.

There were only two "jobs" that needed to be attended to in 2023.

- a) Renewal of the church insurance with Gill & Schmall Agencies by December 5, 2023. There was a difference in premium of \$13,855.00 from \$12,0101.00; an increase in cost of \$1,845.00.
- b) Receiving the baby grand piano. Leona & Elenor saw Don Schmall as to whether there would be any increase to our insurance as to replacement cost (value of \$25,000.00) or our liability coverage. He assured us that our present coverage covers both. No increase or extra costs.

Stewardship Report 2023-24

This is the first Stewardship Report since the formation of our Ecumenical Shared Ministry. The Stewardship Chair position is on the Neepawa United Church Board and the NUASM Board.

Stewardship activities occur throughout the year to support our congregation's mission statement. We spend our time, energy and focus on activities that serve God in our community and the world by following the teaching and example of Jesus Christ, our Lord.

In the past year, several stewardship initiatives were introduced. "Stewardship Seconds" are included in each Friday email as well as on the website, and power point presentations prior to Sunday services. Each unique message focuses on stewardship principles – generosity, gratitude, sharing, and caring.

After three years of limited group activities due to the pandemic, we reintroduced brunches and a fall supper. The congregation responded enthusiastically with their participation, volunteerism and donations. The fellowship of eating together was especially important.

Rev. Chad has added an offertory prayer to each Sunday service, and it references givings on the offering plate as well as through PAR. There has been an increase in the number of donors who give by pre-authorized remittance and this regular income is very helpful in enabling us to do God's work all year.

For the last two years, the Fall Stewardship Campaign has included a Narrative Budget which describes how our church's resources are used throughout the year. It is interesting to note that 29% of the 2023 budget goes towards worship, 9% to Christian development, 26% to pastoral care, 18% to mission and service and another 18% to outreach which includes our donations to local schools, community groups who utilize our facility and the Salvation Army. Jesus calls us to feed the hungry, comfort the lonely and support those in need. Our shared ministry does just that.

Many thanks go out to all the volunteers who assisted with these stewardship initiatives. It takes a church community to do God's work.

Property Report

2023 was a relatively slow year again. We arranged a maintenance agreement with Flynn roofing from Brandon.

This year was the third year of a new snow clearing policy, we continue to have Touchwood clear sidewalks and doorways Monday to Friday. We have hired Doug Wilkinson on weekends rather than have a volunteer schedule. Pat Baker has been doing a wonderful job of clearing the parking lot along with sanding it.

Many thanks to our Touchwood clients for clearing snow and doing our spring and fall cleanups.

Some additional work was done around the outside of the church to trim back trees and shrubs to make it easier to maintain the yard, along with the roofing agreement which should help us.

An AED (Automated External Defibrillator) was purchased and installed in the CEC hall in the fall.

We are thrilled to have the CEC basement carpet taken out and replaced over the holidays.

The UCW meets the first Wednesday of the month at 9:30 in the morning. Our meetings are led by revolving chairs—each of our three units takes a turn providing a chairperson for 3 months at a time.

In 2023 we met regularly and were able to get back to more of our traditional events.

- We continued to visit and call members especially "shut ins" (that might describe many of us at various times through the year!).
- We greet folks at the door on Sunday mornings.
- We've started visiting at Country Meadows again this year.
- We take part in World Day of Prayer and Least Coin Services. We will be hosting both these services here at NUASM in 2024.
- We were able to do our Gently Used Sale in the spring and the fall, bringing in a total of \$7095.10! We have a committee that is really well organized and does a super job!
- At Christmas we acknowledged the hard work of our church staff, and some of the folks who
 do a lot of work behind the scenes to keep things running smoothly.
- We catered 13 funeral lunches, and raised \$13,211.67.
- We worked with many other members of NUASM to put on a Shrove Tuesday Pancake Lunch, which raised \$1185.10!
- We were able to hold our Christmas Party—a time of worship and fellowship and an opportunity to remember the women we've lost in the past year.
- We delivered cookie trays to members of our church family who are alone or unable to get out or have recently lost a loved one.
- We purchased a new "industrial" fridge that is a big help when we are catering.
- We met all our budgeted givings in 2023. And we gave \$10,000 to the Church Board for operating expenses! For more information regarding our annual contributions to various organizations please see the UCW Treasurer's Report, submitted by Elsie Slimmon.

We are thrilled to have the women of St. James Anglican congregation working with us on many of these projects. There is room for everyone. And there are always lots of laughs in the kitchen!

We wish to thank everyone who helps with our events. We truly appreciate the support of the congregation throughout the year. We will continue to do our best to support our Church while honouring God and our place in this Community of Faith. We look forward to 2024!

The Mission, Service and Outreach Committee is here to help us focus on how we can make a difference here, and out there in the world. It's a way for us to share some of what we at Neepawa United-Anglican Shared Ministry have been so richly blessed with!

It is our job, as M, S and O, to bring issues to your attention, provide information and encourage involvement in activities that contribute to the well-being of our neighbours. That is why we continue to read Minute for Mission stories weekly. Of course, we like to include items from PWRDF as often as possible too. This way we can all become more familiar with our wider church missions.

We have many annual projects like White Gift Sunday, the Mitten Tree, the Lenten Calendar and donations for our local schools.

This year we introduced "Cookies for Breakfast" to raise funds for the Breakfast Program at the Middle School since that program was the most in need of our help. We sent \$225.36 to feed hungry kids because we all know it's hard to learn if your stomach is empty!

And we have continued with our teas—where we take goodies, The Hims, and good times to our seniors' residences. All are welcome to join us on these outings—it's a lot of fun—good food, great entertainment, and wonderful visits with folks!

Neepawa United Church Financial Report for 2023

Memorial Fund -- This fund was set up to accept donations in memory of individuals or families and funds to be used only for purchasing items or repairs within the sanctuary. There was \$750.00 donated in memorials during 2023 and no estate donations.

Building Fund – set up many years ago by CNR Still donation to build a new church. Since construction of the new church in 1992 the fund accepts donations annually to the fund by weekly givings through envelopes, PAR, and designated donations. The funds are allocated by the Board to cover costs of major repairs to the facility and for onetime expenses that are not considered normal operating expenses.

General Account -- daily operation of the church. July 1, 2020 the Neepawa United Church entered into an Ecumenical Shared Ministry with St James Anglican Church. St James Anglican Church agreeing to contribute \$2,000.00 monthly towards costs of a full- time minister. Neepawa United Church would continue to be responsible for all other costs of the operation of the Neepawa United Church. This financial arrangement is subject to change by agreement as conditions change. Income and expenses are stable but they too fluctuate during the year. In 2023 both income and expenses were over budget with a year end deficit of \$23,181.21, down from projected budget deficit of \$35,480.00. The Neepawa United Church annually files Canada Revenue Agency's Charity tax return as soon as received. Neepawa also completes and files the annual United Church Statistical report when it becomes available.

The Neepawa United Church is currently in a stable financial position and welcomes the new Ecumenical Shared Ministry with St James Anglican Church and their financial support. Reviewing the deficit for 2023 and projected deficits for 2024 and beyond, there will be continuing need to monitor the financial future of the church.

The financial records of the

Church are reviewed annually by Judith Elgert, and statement issued that is on file.
