Dear Friends in Christ,

When a Christian goes on pilgrimage, they set out with the intention of making a special journey to a sacred place to encounter the holy. Pilgrims walk in the way of the generations of faithful who have gone before them. Praying in the places worn by the countless feet, knees and hands, where prayers have been poured out to God in desperation, thanksgiving, joy, sorrow, and every other human need and emotion that compels those seeking the divine to go to such distances, lengths, heights, and depths.

My wife and I were immeasurably blessed to make pilgrimage to the holy isle of Iona in Scotland this past summer, a deeply spiritual place that has been a Christian pilgrimage site for more than a millennium and a half! Making this journey brought us in direct contact with a depth of Christian spirituality which we are still discerning through. The sheer magnitude of faith that inspired countless Christians to make such a treacherous journey to a wee isle in the middle of the Atlantic Ocean, off the rugged and unforgiving West coast of Scotland, jarred my faith in a seismic way. To say I was inspired and renewed in faith would be an understatement. To say that I came away from that holy ground changed would also be an understatement.

One of those inspired changes within me is a deep desire to repent for my apathy and ungratefulness where my faith is concerned. We have been given so much, especially as North Americans, and I will freely admit that I lose sight of this too often. Those gifts, graces, and mercies are amplified for us as Christians because of the immeasurable gift of eternal life that we have been given by God through Christ, which leaves no room for anything but an outpouring of gratitude.

It strikes me that the NUASM family has been on a sort of pilgrimage these past five years, making a journey into the unknown in faith, seeking a deeper understanding of who we are as Christians, and better ways of leaning into our faith life. Although we continue to walk in the footsteps of the many who have gone before us, we chose very deliberately to make our own path too. Along the way we have experienced times of renewal and growth, but also times of sorrow and bereavement over what no longer is. Along the way we have been shifted in seismic ways, inspired to ponder, discern, and explore new paths, while simultaneously realizing what is vitally important and non-negotiable where our worship life and faith is concerned.

We as Christians who find our spiritual home at NUASM have been changed, and I pray that we do not underestimate the magnitude of what God has done and is doing on the sacred ground that is our Church. I pray that we will be renewed in thanksgiving and inspired fervor as a community of faith and how we engage with the Gospel and those who need to hear it most. As walk upon the pilgrimage paths worn by those who have gone before us as parishioners of Neepawa United and St. James' Anglican, may we continue to build something worthy of God who calls us and sanctifies us for His mission and ministry, leaving a faith worthy of making pilgrimage to in the future.

Board of Trustees Report January 2025

MATINE SECTION AND ADDRESS OF THE PARTY OF T

The insurance policy for the church came up for renewal on Dec 5, 2024. At the general board meeting on Sep 17/24, a discussion was held about the policy, and it was decided that the trustees should check the cost to increase liability limits to \$5,000,000 from \$2,000,000.

In mid November, Gayle and Leila met with Don Schmall of Gill and Schmall Agencies to discuss the policy coverage limits and were advised that cost for this increase would be approximately \$300. At the Nov 19/24 board meeting this increase was approved.

There is no longer a mortgage on the church, but Beautiful Plains Credit Union shows as mortgagee on the policy. There is a line of credit open for the church if needed, and Leila has not heard from Don whether or not the Credit Union needs to appear on the policy for this line of credit.

CWB National Leasing as loss payable for phone components is no longer necessary. Don was to find out if a release letter was needed to remove them from the policy but as of this date he has not responded.

For the 2024/25 policy, limit on building and contents has been increased by Red River to \$5,959,000. This increase is slightly over 6% and is applied every year to help keep up with increased building costs. A replacement cost calculator is completed by Red River every few years to be sure we are keeping up with replacement costs, however one has not been done since 2019. It is expected another will be done this year or next.

Premium for this term is \$14,715 plus the increased liability premium, which has not been billed out yet.

The role of the Stewardship Chairperson is to find opportunities for our church family to share our time, talent and resources with others in the community and our church. Stewardship activities occur all throughout the church year and once initiated, continue year to year.

Stewardship Seconds are short, inspiring messages that you may see on the Friday email, or on the power point presentation prior to worship or on our website. These words help to nurture generous sharing of gifts as disciples of Jesus would do.

Mention of PAR as a way to regularly support our church continues to be done at each Sunday service during the offertory prayer. We have seen a slight increase in the number of donors who choose to support our church family this way and we have seen some givers increase their monthly donation.

The Fall Stewardship Campaign was successful bringing in a significant amount to help toward balancing our finances. A reminder to support end-of-year donations was included in the Friday emails, power point presentation and on the website. The narrative budget outlined in the fall letter showed that 24% of our budget goes toward supporting Worship, 26% is for Pastoral Care, 10% for Christian Development, 17% for Outreach, and Mission and Service support is 18% of our expenses.

Three brunches were held during the year to encourage fellowship and sharing of time together. The menus varied in June, September and December and \$3,000 was raised. These events touch all our congregation through helping, organizing, bringing groceries and enjoying the meals.

Stewardship is all about sharing our gifts with others. Our church family is very good at Stewardship.

UCW Annual Report

The General UCW meets the first Wednesday of the month at 9:30 in the morning. These meetings consist of our executive and representatives of all 3 units as well as sub-committee chairs. Our meetings are led by revolving chairs—each of our three units takes a turn providing a chairperson for 3 months at a time.

In 2024 we met regularly, and were busy with numerous fundraising events as well as pastoral care and fellowship activities.

- We continued to visit and call members especially "shut ins" (that might describe many of us at various times through the year!).
- We greet folks at the door on Sunday mornings.
- We visit and provide a short program at Country Meadows in February, March, April, September, October and November
- We hosted World Day of Prayer and Least Coin Services in 2024.
- We held our Gently Used Sale in the spring and brought in \$3450.65. We have a committee that is really well organized and does a super job!
- At Christmas we acknowledged the hard work of our church staff, and some of the folks who
 do a lot of work behind the scenes to keep things running smoothly, by presenting them
 with gift cards for local business.
- We catered 10 funeral lunches, and raised \$11,122.00
- We worked with many other members of NUASM to put on a Shrove Tuesday Pancake Lunch. We served 127 and raised \$1475.76 which was split 3 ways between UCW, St James and the Middle School Breakfast Program.
- Many UCW members were involved with making blue jean quilts which is a joint service project with the women of Prairie Alliance Church
- We organized a Soup and Sandwich Lunch and Bakesale and raised \$1814.90
- We held our UCW Christmas Party—a time of worship and fellowship and an opportunity to remember the women we've lost in the past year. We sent the offering from that service (449.00) to the NACI breakfast program.
- We delivered cookie trays to members of our church family who are alone or unable to get out or have recently lost a loved one.
- We purchased extra shelves for the cooler in the kitchen.
- We met all our budgeted giving's in 2024. And we gave \$6,000 to the Church Board for operating expenses. And we sent \$2000 to Mission and Service, as we have in the past. For more information regarding our annual contributions to various organizations please see the UCW Treasurer's Report, submitted by Elsie Slimmon.

We are thrilled to have the women of St. James Anglican congregation working with us on many of these projects. What a great way to get to know each other! There are always lots of laughs in the kitchen! We wish to thank everyone who helps with our events. We truly appreciate the support of the congregation throughout the year. We will continue to do our best to support our Church while honouring God and our place in this Community of Faith. We look forward to 2025!

Mission, Service and Outreach

It was another busy year for Mission, Service and Outreach!

- We started our year by disassembling the outdoor nativity scene. Murray Newton does the
 heavy lifting on this—he gathers everything up and takes it away to store safely till November!
 Makes our job so much easier! And we put away the mitten tree and delivered the last items to
 Salvation Army.
- In February we prepared the Lenten Calendar and spent a day sewing baby quilts for baptisms!
- In April we hosted a games night and played Earth Day Bingo to focus on climate issues. The bingo prize was a very healthy tomato plant that Dawn started in the office window!
- In May we organized two Spring Teas with the help of The Hymns—one at Yellowhead Manor and one at Kinsmen Kourts. Thank you to everyone who comes out to these teas. It's a wonderful way to visit with folks we might not see otherwise, and we know the residents really enjoy these mornings!
- Because we had so much fun at the Games Night in the spring, we had another one in September! If you haven't been to one of these, you really should give it a try. It's good fun and all the junk food and treats you can handle!
- We arranged for Ray Baloun from the Canadian Foodgrains Bank to come and speak at a Sunday Service in October.
- We organized an evening with the women of Prairie Alliance Church, starting work on blue jean quilts for the Bear Clan in Brandon. We'll be meeting a couple more times in 2025 to complete this project.
- We arranged a Fall Tea at Elks Manor. And The Hymns were able to join us again. It would not be the same without them!
- In time for Advent, we had Murray Newton bring the outdoor nativity out of storage and back to the stable. We really want to thank Murray, and Grant Babcock who helped us with lighting this year!
- Early in December we hosted an appreciation lunch for the Palliative Care Team—with lots of help from Chad and members of the congregation and Blair Chapman who provided wonderful background music. And December 15th was White Gift Sunday -- we brought new, unwrapped toys to church and they were then delivered to Salvation Army for children in our community.
- We occasionally provided cookies for coffee time before Sunday service and encouraged folks to make donations to our "Cookies for Breakfast" program. We delivered a cheque for \$277.40 to the middle school for their breakfast/snack program. Speaking of cookies...Nancy Hunter did her "Cookies for Change" program again with all the proceeds being sent to Doctors without Borders. Neepawa United Church Financial Report for 2024

<u>Memorial Fund</u> – this fund was set up to accept donations in memory of individuals or families and funds to be used only for purchasing items or repairs with the sanctuary. There was \$810.00 donated in memorials during 2024 and no estate donations.

<u>Building Fund</u> – this fund was set up many years ago by the CNR Still donation to build a new church. Since construction of the new church in 1992 the fund accepts donations annually which are allocated by the Board to cover costs of major repairs to the facility and for one-time expenses that are not considered normal operating expenses.

<u>General Account</u> – is for the daily operations of the church. July 1 2020 the Neepawa United church entered into an Ecumenical Shared Ministry with St. James Anglican church. St. James agreed to contribute towards costs of a full-time minister and Neepawa United would continue to be responsible for all other costs of operation of the Neepawa United Church. This financial arrangement is subject to change by agreement as condition change. In 2024 income was over budget as a large donation of \$25,000.00 was received and expenses were under budget with a year end net income of \$8,134.61.

The Neepawa United Church annually files a Canada Revenue Agency Charity Tax Return which is due June 30, 2025. Neepawa also completes and files the annual United Church Statistical report when it becomes available.

The financial records are reviewed annually and we are currently looking for someone to replace me as the reviewer.
